#### **VA Survivors Pension**

A VA Survivors Pension offers monthly payments to qualified surviving spouses and unmarried dependent children of wartime Veterans who meet certain income and net worth limits set by Congress. Find out if you qualify and how to apply.

#### Am I eligible for a VA Survivors Pension as a surviving spouse?

You may be eligible for this benefit if you haven't remarried after the Veteran's death, and if the deceased Veteran didn't receive a dishonorable discharge and their service meets at least one of the requirements listed below.

#### At least one of these must be true. The Veteran:

- Entered active duty on or before September 7, 1980, and served at least 90 days on active military service, with at least 1 day during a covered wartime period, or
- Entered active duty after September 7, 1980, and served at least 24 months or the full period for which they were called or ordered to active duty (with some exceptions), with at least 1 day during a covered wartime period or
- Was an officer and started on active duty after October 16, 1981, and hadn't previously served on active duty for at least 24 months

#### And this must be true for you:

- Your yearly family income and net worth meet certain limits set by Congress. Your net worth equals the value of everything you own (except your house, your car, and most home furnishings), minus any debt you owe.
- Am I eligible for a VA Survivors Pension as the child of a deceased wartime Veteran? You may be eligible for this benefit if you're unmarried and you meet at least one of the requirements listed below.

#### At least one of these must be true:

- You're under age 18, or
- You're under age 23 and attending a VA-approved school, or
- You're unable to care for yourself due to a disability that happened before age 18

#### **Retiree Pay-Raise**

Starting in 2022, military retirees and disabled vets are due to get the largest increase in their monthly checks since 1983. Many will see their monthly checks jump by hundreds of dollars. The COLA (Cost of Living Adjustment) will soon be determined by the government, and all the data is pointing to an increase of at least 6% compared to 2021.

#### **TRICARE Sets Dates for 2021 Open Season**

TRICARE's 2021 Open Season will run Nov. 8 through Dec. 13, giving eligible beneficiaries a little more than a month this fall to make changes to their coverage.

Anyone enrolled in, or eligible for, a TRICARE Prime or TRICARE Select plan can enroll in a plan or make changes to their coverage during this period. Updates would take effect Jan. 1, 2022.

Reenrollment is not required; if you like the plan you're in, you'll continue with it as long as you remain eligible.

Coverage changes outside Open Season require a Qualifying Life Event (QLE). You'll have 90 days after a QLE to make changes; a QLE for any family member allows all family members to change health plans. Get a list of these events and details on how to initiate enrollment changes after a QLE at TRICARE.mil/life events.



### 3rd VICE PRESIDENT — LEGISLATIVE & Community Activities

It's time to **exercise our right and duty to vote**. Although there are no State or Congressional seats up for grabs, there are eight constitutional amendments to consider. Here's a copy of the actual ballot for the November 2021 election -

Although this is a Denton County ballot, every county ballot will feature these same eight proposals. The Texas League of Women Voters provides an explanation for each, as well as their individual pros and cons -

Proposition 8 directly affects some military families. It is - "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a member of the armed services of the United States who is killed or fatally injured in the line of duty." Current Texas law limits this exemption to the families who lose active-duty service-members in combat.

The Texas Legislature is wrapping up its third special election, spending most of its time reworking voting districts. Although there are a number of proposed changes in the North Texas area, I see only one proposal in west Texas that affects a military installation. Ft. Bliss, currently in District 16 and includes El Paso, would join District 23, which includes San Antonio. It's unclear if that would improve or degrade federal funding opportunities for Fort Bliss, which would be just another military installation already in the San Antonio area, rather than "the only game in town." Presumably, the special session will end on 20 October. However, Governor Abbott can call another special session if he feels there are still legislative priorities that he wants addressed. Governor William Clements holds "the record" for most special sessions in a given year, six, that lasted from July 19,1989 until June 1990.





#### What's Up in Congress

On September 30<sup>th</sup>, Congress passed a continuing resolution to keep government operations from shutting down...at least until December 3<sup>rd</sup>. That gives them nine more weeks to pass a fiscal 2022 budget plan for the military and the rest of the federal government. In the meantime, House and Senate leaders will begin discussing the differences

between the two versions of the NDAA and hopefully reach a conference agreement that will pass both chambers.

Here are a few highlights, in case you're wondering what's in the NDAA:

- The \$740+ billion 2022 National Defense Authorization Act includes provisions to overhaul the military justice system's handling of sexual assault cases. The bill would remove superiors from the direct chain of command from making decisions in sexual assault cases.
- The bill authorizes a 2.7 percent pay increase for service members.
- Section 720 of the NDAA establishes procedures for which service members can be exempted from taking the COVID-19 vaccine for religious, medical, and administrative reasons, including a test showing antibodies from a previous COVID-19 infection. Section 716 requires the Pentagon to honorably discharge any service member who refuses the vaccine (but doesn't qualify for an exemption).
- The bill also creates a new "Office of Countering Extremism" that could be used to discipline and expel troops who engage in "extremist activities" or belong to an "extremist organization."

It would require women to register for the Selective Service, also known as the draft, for the first time in our nation's history.

## Surviving Spouse Liaison Debby Allbach

Surviving Spouses virtual chapter is a no cost MOAA chapter the purposes of which are:

- \*Provide information and exchange ideas
- \*Find solutions to problems or issues affecting surviving spouses
- \*Be a resource for surviving spouses
- \*Reach out to younger surviving spouses and to those living where MOAA chapters are not available
- \*Be an enhancement to regular chapters—the virtual chapter does not take the place of a regular MOAA chapter.

The Chapter meets every month on the 3rd Tuesday, alternating between the traditional business meeting at 1200 noon central time on "odd" months (i.e., November, January etc) and a social gathering/open forum at 4 pm central time on "even months (i.e. December, February etc).

The September meeting was very informative with 2 interesting presentations. The first: Judith Thomas, a member of the Virtual Chapter, represents the Vietnam War Commemoration Commission through the Society of Military Widows. She presented information on The United States Vietnam War Commemoration Commission, authorized by Congress in 2008 to recognize Veterans who honorably served on active duty in the United States military between November 1, 1955 and May 15, 1975, no matter where that service occurred. The service is recognized by a pin and a certificate. Surviving Spouses of eligible veterans can also apply to receive a pin and certificate. To date, Judith has mailed out over 3000 pins. The recognition can be requested through Judith at her email, jktmilitarywidow@gmail.com by providing the mailing address of the requesting individual, the name of the service member, the branch of the military and the dates of service. The form is simple and there is no requirement to submit a copy of the DD-214. The recognition comes in two separate packages, a box for the pin and a flat envelope for the certificate. To date, about four million veterans have been recognized, approximately 10 per cent of which are through surviving spouses. The program will continue until 11 November 2025. The intent is to capture individual veteran's stories so that they are available to the public. Their voices will tell future generations "I was there, and this is what it was like". The interviews span WWI through the present. The book is available through Amazon. Copies are available to veterans for \$20, which is \$5 less than through the internet. Additionally, a member updated information about the Battle of Mogadishu in October 1993. All the soldiers of the Delta Force involved in that incident will have their awards updated. Twenty-eight years after the fact, they are still being remembered and The Mogadishu Mile is run in commemoration of Rangers who were left behind and had to run about a mile from the center of Mogadishu to the stadium. This year it will be run across the country. You can sign up to participate on the MOAA website; running is not required, participants can walk or just sit and have a cup of coffee with a friend. The important thing is to remember. "Never Forget".




